ISSUE

PROBLEM

There is no federal protection prohibiting race, sex, and/or gender expression-based hair discrimination.

SOLUTION

The Equality Act supports the protections provided by the Crown Act: prohibiting race, sex, and/or gender expressionbased discrimination, in this case, related to how Black people express gender through hairstyles, including braids, locs, twists, or Bantu knots.

Signed into law in eight states, this bill prohibits race-based hair discrimination, like denial of employment or educational opportunities.

PROBLEM


There is no federal protection prohibiting discrimination related to accessing federally-funded programs (through nonprofits, Community Based Organizations, contractors, government agencies, etc.).

SOLUTION

The Equality Act adds civil rights protections for every person using federally-funded public programs, including disaster relief, food assistance, and those attached to the criminal punishment and child welfare systems (prisons, probation officers, social workers, etc). It will provide a federal legal remedy for much of the systemic and routine discrimination that Black people experience.



PROBLEM
